Special Exceptions

Attorneys, Architects, CPA's, Engineers, Physicians/Dentists and other professionals: \$289.00 plus \$25 per additional associate

Real Estate: \$300.00 up to 5 agents; \$400.00 6 - 10 agents; \$500.00 11 - 20 agents; \$600.00 20 + agents

Builders, Industry & Manufacturers: \$289.00 plus \$2 per employee (\$1 per employee over 500)

Motels, Hotels, Inns, Lodges, Nursing Homes, Retirement Complexes: \$289.00 plus \$2 per unit

Churches, Civic Clubs, and other 501 (c)(3) Organizations: \$281.00

Financial Institutions (Banks, Savings Banks, Savings & Loans): \$289.00 plus \$5 per million dollars on local deposit up to \$25 million; \$10 per million for the next \$75 million and \$5 per million thereafter
